**WHEREAS**, Section 31-3204, Idaho Code, has been amended effective July 1, 2014 that increases the victim notification fee from \$10.00 to \$15.00 for each conviction of a misdemeanor count; and

**WHEREAS**, The Idaho Supreme Court has amended its schedule of bonds that may be posted for misdemeanor offenses effective July 1, 2014,

**NOW, THEREFORE, IT IS HEREBY ORDERED** that the amended list of payable offense as reflected on Attachment A to this order is adopted for offenses committed on or after July 1, 2014.
